Name	Communications and Knowledge Sharing Committee (C&KS)
Role and Purpose	<p>The primary role and purpose of the C&KS is to:</p> <p>Develop and implement a Communications and Knowledge Sharing Strategy to increase the profile of ICSEI, including attention to: ICSEI social media, website oversight, ICSEI Dialogic, academic/research and other publications, and other Communications & Knowledge Sharing actions as considered appropriate.</p>
Objectives	<p>The objectives of C&KS include:</p> <ol style="list-style-type: none"> 1. Design and deliver a C&KS strategy and plan to raise awareness of ICSEI and to contribute to increased ICSEI membership and Congress attendance; 2. Establish an Editorial Review Panel; 3. Ensure continued quality communications from ICSEI to members between Congresses; 4. Raise profile of ICSEI in wider public communications and in targeted communications for researchers, policy makers and/or practitioners; 5. Support quality content of the newly launched ICSEI website; 6. Increase engagement by and with ICSEI social media platforms, including Facebook, LinkedIn and Twitter; 7. Produce ICSEI Dialogic (minimum 2 per year); 8. Oversee high quality ICSEI research-related publications, for example ICSEI Monograph Series, Keynote Series, and Book Corner Series; 9. Adhere ICSEI's Ethical Statement on Generational Renewal, Inclusion and Diversity. 10. Ensure the consistency and alignment of ICSEI communications.
Authority and Delegation	<p>The Committee may not make policy decisions or incur expenditure outside Budget, without approval by the Board (or the Executive Committee if the matter is urgent) unless these matters have been previously specifically delegated to the Committee.</p> <p>Any Board delegations to the Committee are subject to their being exercised in accordance with:</p> <ul style="list-style-type: none"> · The Constitution · ICSEI policies, including the Code of Conduct and the Ethical Statement · The Budget approved by the Board · Any requirements on reporting and making recommendations to the Board
